

**AGREEMENT BETWEEN  
THE FUDAN UNIVERSITY OF SHANGHAI  
AND THE UNIVERSITY OF NAPLES FEDERICO II**

The University of Naples Federico II, Represented by its Rector Gaetano Manfredi  
and the **Fudan University of Shanghai**, represented by its Rector/President pro-tempore ...  
have decided to establish the scientific, educational and training cooperation.

The Parties have agreed upon the following:

**ARTICLE 1 – Forms of cooperative activities**

The main goals of the cooperation will cover the following activities:

- study missions;
- exchange of students, lecturers and researchers;
- organization of interviews, seminars and scientific meetings;
- exchange of scientific and educational papers;
- development of projects and courses of lectures estimated useful by both parties.

**ARTICLE 2 – Fields of application**

The two contracting parties will actively cooperate in the field of **American philosophy** and in **philosophy of education**, in a particular manner in **the work of John Dewey in the whole its interdisciplinary spectrum (ranging from philosophy to psychology, from education to political theory, from the reflection on the curriculum to philosophy of technology)** as well as in other teaching fields that may be defined afterwards.

**ARTICLE 3 – Exchange of lecturers, researchers**

The two contracting Universities will accomplish the exchange and invitation of lecturers-researchers as follows:

- short visiting missions (conferences, joint scientific meetings);
- medium.term missions (from 4 to 6 weeks);

Every year the two Universities will set in agreement the number of lecturers-researchers (within a maximum of five) to engage in the exchange visit, as well as the length of the mission.

**ARTICLE 4 – Exchange of relevant publications**

The two contracting Universities will mutually acquaint information on scientific papers as well as their educational programs and research projects.

They exchange, within the fields of the agreement, periodical and eventually non periodical scientific papers.

#### ARTICLE 5 – Financial resources

The two contracting Universities will be engaged in raising funds to consent the accomplishment of the goals defined by the present agreement.

#### ARTICLE 6 – Duration of agreement

The present agreement will be in effect for a period of three years and can be renewed. Either party may terminate it upon six months prior notice to the other. The present Agreement will come into force after its stipulation on the side of the qualified authorities of both the University parties.

#### ARTICLE 7 – Responsible and joint committee

The fulfilment of this Agreement will be coordinated by the University of Naples whose representative is prof. **Maura Striano**, of the **Department of Studi Umanistici [Humanities]**.

The fulfilment of this Agreement will be coordinated by the **Fudan University** whose representative is prof. ... of the Department of .....

To elaborate the annual plan of cooperation and the financial plan of activities, the assigned work, programming and coordination of all the activities written in the present Agreement will be carried out by a joint committee, formed by six members (three from Naples, three from Fudan University) comprehending the coordinators.
