# Art. 1 Object

1. These Didactic Regulations govern the organisational aspects of the CdS in Philosophy (class LM-78), which is hinged on the Department of Humanities.

- 2. The CdS is governed by the Didactic Coordination Commission (CCD), pursuant to Art. 4 of the RDA.

A **sub-committee** was set up in the BoD approved on 09.04.2024 p. 6.7, with reference to Art. 4, paragraph 4, letter n of the University Didactic Regulation concerning the competences of the CCD indicated in the same Art. 4, paragraph 4, letters b), c), d).

3. The Didactic Regulations are issued in compliance with the relevant legislation in force, the Statute of the University of Naples Federico II, and the RDA.

# Art. 2

# **Training objectives**

The Master's degree course aims to provide advanced historical-philosophical as well as theoretical preparation, consolidating analytical, evaluative, and logical-argumentative skills in relation to the various forms of knowledge and thus enabling the refinement of skills useful for analyzing and understanding the contemporary world.

More specifically, graduates of the Master's Course acquire a thorough knowledge of the philosophical tradition and a marked ability to establish connections between conceptual nuclei and historical periods. A remarkable historical-conceptual preparation is accompanied by hermeneutic-critical competence supported by an adequate awareness of the problems connected with the interpretation of texts and historiographic methodology.

Another central objective of the training course is the acquisition of specific skills in relation to the areas that concern the analysis of subjectivity framed within its philosophical-anthropological horizon and, thus, in relation to both the natural environment and the social world. Central to this are the ethical-practical, aesthetic, political and religious dimensions.

The master's degree student will also have to acquire a secure ability to use theoretical and methodological tools that enable autonomous research, reflection and critical capacity. He/she must be able to argue, discuss and defend his/her theses, also showing an adequate use of the Italian language both in oral and written production. In particular, he/she must show an adequate

competence in the production of scientific texts proper to the various theoretical models of the discipline.

The educational objectives of the Course of Studies are structured around the philosophical subject areas, suitably specified in specialised courses and according to educational paths congruent with the objectives formulated above, as indicated in Article 9 of these didactic regulations. The structure of the two-year course is designed starting from the identification of the three macro-areas (historical area, theoretical area, moral area) with six compulsory courses to be chosen from 14, with the choice always possible between at least two alternatives. To these compulsory courses are added four related and supplementary courses to be chosen. Choices may be free or oriented on the basis of pathways (cf. Art. 9).

The two-year master's degree program includes a wide range of collateral initiatives (Classics Workshops, *Guest Lectures* held by *Visiting Professors*, Conferences, Seminars, etc.), which are instrumental in achieving a high level of cultural and critical maturity.

# Art. 3 Professional profile and work opportunities

# 1. SPECIALISTS IN PUBLIC RELATIONS, IMAGE AND RELATED PROFESSIONS

#### **Function in a work context:**

The Master of Philosophy graduate can promote public relations and the image of a company or organisation with a particular qualification in the cultural field by writing texts, selecting and disseminating publicity material, organising events of particular importance and visibility, charitable activities, etc.

## Competencies associated with the function:

The course of study provides the aspiring public relations specialist with a solid philosophical and humanistic background, contributing to the development of his analytical, argumentative, and intervention skills, making him suitable for promoting the image of companies and organisations.

# **Employment opportunities:**

- Press officer;
- Image consultant;
- Expert in public relations and corporate communications;
- Spokesperson in public administrations;
- Public relations office editor.

# 2. HUMAN RESOURCES SPECIALISTS

## **Function in a work context:**

The Master of Philosophy graduate can handle personnel recruitment, job application analysis, and interviews and can help define career development criteria and programmes by coordinating personnel training.

## Competencies associated with the function:

By providing a solid historical-critical background on texts relating to ethical, legal-political and applied ethical reflection together with analytical and logical-argumentative competence in relation to the different forms of knowledge and languages relating to them, as well as the different modes characterising man's expressive and communicative capacities, the course of study will train a problem-setting and problem-solving specialist with analytical and intervention skills as well as the ability to coordinate and manage work groups.

# **Employment opportunities:**

Graduates will be able to work for employment agencies, labour consultants, commercial firms and, more generally, companies of all sectors and sizes as career analysts and career counsellors.

## 3. PHILOSOPHY

#### **Function in a work context:**

The Master of Philosophy graduate can conduct research in philosophical historiography, epistemology, metaphysics, ethics, aesthetics, and philosophy in general.

## Skills associated with the function:

By fostering the development of analytical and critical skills, argumentative and expository abilities, and of knowledge of cultural and scientific dynamics, the course of study will train researchers who will be able to enter (in compliance with the competition procedures envisaged by the regulations in force) the PhD programme or specialisation schools in foundations and public and private research bodies, holding management, coordination, collaboration or simple support roles depending on the research carried out from time to time, which may concern the fields of philosophy. The study course also prepares students for consultancy and promotion activities aimed at fostering corporate social responsibility in public and private entities.

# **Employment opportunities:**

- Researcher within public and private research institutions, after having passed a competition or otherwise in accordance with the regulations in force;
- Business consultant.

#### 4. EMPLOYMENT GUIDANCE COUNCILLORS

#### Function in a work context:

The Master of Philosophy graduate can assess individuals' professional propensities, inform them about the structure and dynamics of the labour market, and assist them in identifying the most appropriate paths to personal, social, educational, and professional development and growth.

#### Competences associated with the function:

By fostering the development of specific disciplinary competencies combined with the capacity for critical analysis of cognitive processes, reflection and understanding in the areas that affect human life in its relationship with the natural and social environment, including the aesthetic and religious dimension, as well as the gender dimension, the course of study will train a specialist capable of assessing the propensity of individuals to work in companies or public institutions.

# 5. EDITORS OF TECHNICAL TEXTS

#### **Function in a work context:**

The Master of Philosophy graduate can write manuals, guides, technical appendices, brochures, information texts and instruction booklets for consumer goods, machines and equipment.

# Competences associated with the function:

By fostering the acquisition of analytical, evaluative and logical-argumentative skills, the course of study will be able to gather the necessary information on the products to be described, report the information clearly for the target audience, take care of the revision and updating of the text, revise and edit texts according to the target audience and media.

# **Employment opportunities:**

- Technical text editor at publishing houses, TV and radio channels, websites;
- Editor of technical manuals.

#### Art. 4

# Admission requirements and knowledge required for access to the Degree Program<sup>1</sup>

A three-year degree is required for admission to the Master's Degree Course in Philosophy, guaranteeing a solid basic, methodological and historical training in philosophical studies; a written and oral command of at least one European Union language (at B1 level and above), in addition to Italian.

All students in possession of a three-year degree in Philosophy (L-5 or Class 29 ex-Ministerial Decree 509), from any University, may enrol. Students in possession of a three-year degree in History (Class L-42 for Ordinary DM 270/2004, Class 38 for Ordinary DM 509/1999) and in Classical Literature or Modern Literature (Class L-10) are also admitted.

In addition, students holding a degree similar to a Bachelor's degree, obtained in a foreign country belonging to the EU or, in any case, in a country that has accepted the ECTS system, may be admitted to the Master's Degree Course in Philosophy.

On the other hand, students who hold a Bachelor's degree, or similar, obtained in a non-EU country, including degrees awarded by university institutions of the Holy See (i.e. Baccalaureate or Licence), may apply for admission to the Master of Philosophy degree course, only after obtaining a "Dichiarazione di valore" at the Italian embassy in loco, i.e. legalisation or endorsement by the Holy See.

CCD will then assess each request on a case-by-case basis, taking into account the indications from CIMEA (Centre for Information Mobility and Academic Equivalences, https://www.cimea.it).

## Art. 5

# Procedures for access to the Degree Program (CdS)

The CCD of the Degree Program normally regulates the admission criteria and any scheduling of enrolments, except in cases subject to different provisions of law2.

**DSU Regulation CdSM Philosophy** 

Personal preparation is ascertained through an examination of the graduate's university career and an interview. The interview, to be conducted by the Educational Coordination Committee, will discuss and analyse the student's career to identify critical points and gaps in the course and check that they have been made up.

Graduates of classes L-5, L-10 and L-42 and all three-year graduates of the classes indicated who, in addition to meeting the curricular requirements indicated, have also obtained their degree with a mark of at least 85/110, are considered to be in possession of adequate personal preparation and are therefore exempt from the interview.

#### Art. 6

# Teaching activities and university training credit (Teaching activities and CFU)

The CdS detail sheet prescribes each training activity, which is measured in CFU. Each CFU corresponds to 25 hours of overall training commitment,<sup>3</sup> per student and includes the hours of teaching activities specified in the curriculum as well as the hours reserved for personal study or other individual training activities.

For the Degree Program covered by these Didactic Regulations, the hours of teaching specified in the curriculum for each CFU, established in relation to the type of training activity, are as follows.<sup>4</sup>:

Lecture or guided teaching exercises:
 Seminar:
 Laboratory activities or fieldwork:
 5 hours per CFU;
 8 hours per CFU;
 25 hours per CFU.

The CFU corresponding to each training activity acquired by the student is awarded by satisfying the assessment procedures (examination, pass mark) indicated in the Course sheet relating to the course/activity attached to these Didactic Regulations.

# Art. 7 Description of teaching methods

The didactic activity is carried out entirely in person, through lectures, seminars, and laboratory activities, or, and to the extent of no more than one-tenth of the total, through multimedia teaching (distance or blended learning).

If necessary, the CCD decides which courses also include teaching activities offered online.

Some courses may also take place in seminar form and/or involve classroom exercises, language, and computer laboratories.

Detailed information on how each course is conducted can be found in the course sheets.

## Art. 8

# Testing of training activities<sup>5</sup>

- 1. The CCD, within the prescribed regulatory limits<sup>6</sup>, establishes the number of examinations and other means of assessment that determine the acquisition of credits. Examinations are individual and may consist of written, oral, practical, graphical tests, term papers, interviews, or a combination of these modes.
- 2. The examination procedures published in the course sheets and the examination schedule will be made known to students before the start of classes on the Department's website.<sup>7</sup>
- 3. Examinations are held subject to booking, which is made electronically. If a student is unable to book an exam for reasons that the President of the Board considers justifiable, the student may still be admitted to the examination, following those students already booked.
- 4. Before the examination, the President of the Board of Examiners verifies the student's identity. The student must present a valid photo ID.
- 5. Examinations are marked out of 30. Examinations involving an assessment out of 30 shall be passed with a minimum mark of 18; a mark of 30 may be accompanied by honours by a unanimous vote of the Board. Examinations are marked out of 30 or with a simple pass mark. Assessments following tests other than examinations are marked out with a simple pass mark.
- 6. Oral exams are open to the public. If written tests are scheduled, the candidate has the right to see his/her paper(s) after correction.
- 7. The University Didactic Regulations govern Examination Boards 8.

## Art. 9

# **Degree Program structure and Study Plan**

The legal duration of the Degree Program is 2 years.
 It is also possible to enrol through a contract in accordance with the university's rules (Art. 21 of the University Teaching Regulations).

The student must acquire 120 CFU.9, attributable to the following Types of Training Activities (TAF):

- 2. The degree is awarded after having acquired 120 CFU by passing examinations not exceeding 12, including the final and the performance of other training activities.
  - Unless otherwise provided for in the legal framework of University studies, examinations taken as part of basic, characterising, and related or supplementary activities, as well as activities chosen autonomously by the student (TAF D) are taken into consideration for counting purposes. Examinations or assessments relating to activities independently chosen by the student may be taken into account in the overall calculation corresponding to one unit.<sup>11</sup>. Tests constituting an assessment of suitability for the activities referred to in Article 10, paragraph 5, letters d) and e) of Ministerial Decree 270/2004<sup>12</sup> are excluded from the count. Integrated Courses comprising of two or more modules are subject to a single examination.
- 3. In order to acquire the CFU relating to independent choice activities, the student is free to choose among all the Courses offered by the University, provided that they are consistent with the training project. This consistency is assessed by the Didactic Coordination Commission. Also, for the acquisition of the CFU relating to autonomous choice activities, "passing the exam or other form of profit verification" is required (Art. 5, c. 4 of Ministerial Decree 270/2004).
- 4. The study plan summarises the structure of the Degree Program, listing the envisaged teachings broken down by course year and, in case, by curriculum.
  - The plan is divided into two pathways, which, within the framework of the common training objectives, allow in-depth philosophical training through two different theoretical cores. The pathways are:
    - a. Philosophy and historical knowledge.
    - b. Philosophies of the subject. Anthropology, phenomenology, hermeneutics and philosophy of mind.

In the end, the propedeuticities envisaged by the Degree Program are listed. **Annex 1** to these Didactic Regulations sets out the study plan offered to students, with an indication of the

- scientific-disciplinary sectors and the area to which they belong, of the credits, and of the type of educational activity.
- 5. Pursuant to Art. 11, paragraph 4-bis, of Ministerial Decree 270/2004, it is possible to obtain the Degree according to an individual study plan that also includes educational activities different from those specified in the Didactic Regulations, as long as they are consistent with the CdS detail sheet of the academic year of enrollment. The individual study plan is approved by CCD.

## Art. 10

# Attendance requirements<sup>13</sup>

- 1. In general, attendance of lectures is strongly recommended but not compulsory. In the case of individual courses with compulsory attendance, this option is indicated in the relative teaching/activity course sheet available in **Annex 2**.
- 2. If the lecturer envisages a different syllabus modulation for attending and non-attending students, this is indicated in the individual Course details published on the CdS web page and on the teacher's UniNA website.
- 3. Attendance at seminar activities that award training credits is compulsory. The relative modalities for the attribution of CFU are the responsibility of the CCD.

## Art. 11

# Prerequisites and prior knowledge

- 1. The list of incoming and outgoing propedeuticities (necessary to sit a particular examination) is at the end of **Annex 1** and in the teaching/activity course sheet (**Annex 2**).
- 2. Any prior knowledge deemed necessary is indicated in the individual Teaching Schedule published on the course webpage and on the teacher's UniNA website.

# **Degree Program Calendar**

The Degree Program calendar can be found on the Department's website well before the start of the activities (Art. 21, c. 5 of the RDA).

## **Art. 13**

# Criteria for the recognition of credits earned in other Degree Programs in the same Class<sup>14</sup>

For students coming from Degree Programs of the same Class, the Didactic Coordination Commission ensures the full recognition of CFU when associated with activities that are culturally compatible with the training Degree Program acquired by the student at the originating Degree Program, according to the criteria outlined in Article 14 below. Failure to recognise credits must be adequately justified. It is without prejudice to the fact that the number of credits relating to the same scientific-disciplinary sector directly recognised by the student may not be less than 50% of those previously achieved.

Criteria for the recognition of credits acquired in Degree Programs of different classes, in university or university-level Degree Programs, through single courses, at online Universities and in international Degree Programs<sup>15</sup>; criteria for the recognition of credits acquired in extra-curricular activities

- 1. With regard to the criteria for the recognition of CFU acquired in Degree Programs of different Classes, in university or university-level Degree Programs, through single courses, at online Universities and in International Degree Programs, the credits acquired are recognised by the CCD on the basis of the following criteria:
  - analysis of the activities carried out;
  - evaluation of the congruity of the disciplinary scientific sectors and of the contents of the training activities in which the student has earned credits with the specific training objectives of the Degree Program and of the individual training activities to be recognised.

Recognition is carried out up to the number of credits envisaged by the didactic system of the Degree Program. Failure to recognise credits must be adequately justified. Pursuant to Art. 5, c. 5-bis, of Ministerial Decree 270/2004, it is also possible to acquire CFU at other Italian universities on the basis of agreements established between the concerned institutions, in accordance with the regulations current at the time. <sup>16</sup>.

- 2. Any recognition of CFU relating to examinations passed as single courses may take place within the limit of 36 CFU, upon request of the interested party and following the approval of the CCD. Recognition may not contribute to the reduction of the legal duration of the Degree Program, as determined by Art. 8, c. 2 of Ministerial Decree 270/2004, except for students who enrol while already in possession of a degree of the same level 17.
- 3. With regard to the criteria for the recognition of CFU acquired in extra-curricular activities, within the limit of 12 CFU, the following activities may be recognised:
  - Professional knowledge, skills, and certified skills, taking into account the congruence of the
    activity carried out and/or of the certified skill with the aims and objectives of the Degree
    Program, as well as the hourly commitment of the duration of the activity.
  - Knowledge and skills acquired in post-secondary-level training activities, which the University contributed to developing and implementing.

# Art. 15 Criteria for enrolment in individual teaching courses

Enrolment in individual teaching courses, provided for by the University Didactic Regulations<sup>18</sup>, is governed by the "University Regulations for enrolment in individual teaching courses activated as part of the Degree Program"<sup>19</sup>.

# Features and modalities for the final examination

The final examination for the Master's Degree Program consists of the public discussion of a written thesis, coherently organised and subdivided into chapters, before a commission composed on the basis of the indications given in the University's teaching regulations. This thesis, written under the guidance of a lecturer and supervisor, must show that the candidate has been able to set up and conduct research in one of the disciplines covered by the CdSM, demonstrating cultural maturity and solid critical competence and obtaining a research result of an original nature. The final assessment will be determined by the committee on the basis of the sum of the mark obtained from the discussion of the thesis (up to eleven points) and the average mark obtained in the profit examinations translated into 100ths. The degree may be awarded with distinction provided that the committee is unanimous in awarding it.

In order to be admitted to the Final Examination, the student must have acquired the number of CFUs laid down in the Didactic Regulations of the Master's Degree Course minus the CFUs laid down for the Final Examination.

# **Article 17**

# **Guidelines for traineeship and internship**

- 1. Students enrolled in the Degree Program may decide to carry out internships or training periods with organisations or companies that have an agreement with the University. Traineeship and internship are not compulsory and contribute to the award of credits for the other training activities chosen by the student and included in the study plan, as provided for by Art. 10, par. 5, letters d and e, of Ministerial Decree 270/2004<sup>20</sup>.
- 2. The CCD regulates the modalities and characteristics of traineeship and internship with specific regulations.
- 3. The University of Naples Federico II, through the activities promoted in the field of outgoing guidance (www.orientamento.unina.it) and job placement (www.jobservice.unina.it), ensures constant contact with the world of work to offer students and graduates of the University concrete opportunities for internships and work experience and to promote their professional integration.

# **Article 18**

# Disqualification of student status<sup>21</sup>

A student who has not taken any examinations for eight consecutive academic years incurs forfeiture unless his/her contract stipulates otherwise. In any case, forfeiture shall be notified to the student by certified e-mail or other suitable means attesting to its receipt.

# **Article 19**

# Teaching tasks, including supplementary teaching, guidance, and tutoring activities

1. Professors and researchers carry out the teaching load assigned to them in accordance with the provisions of the RDA and the Regulations on the teaching and student service duties of

- professors and researchers and on the procedures for self-certification and verification of actual performance<sup>22</sup>.
- 2. Professors and researchers must guarantee at least two hours of reception every 15 days (or by appointment in any case granted no longer than 15 days) and, in any case, guarantee availability by e-mail.
- 3. The tutoring service orients and assists students throughout their studies and removes the obstacles that prevent them from adequately benefiting from attending courses, also through initiatives tailored to individuals' needs and aptitudes.
- 4. The University ensures guidance, tutoring and assistance services and activities to welcome and support students. These activities are organised by the Schools and/or Departments under the coordination of the University, as established by the RDA in Article 8.

# Evaluation of the quality of the activities performed

- 1. The Didactic Coordination Commission implements all the quality assessment forms of teaching activities envisaged by the regulations in force according to the indications provided by the University Quality Presidium.
- 2. In order to guarantee the quality of teaching to the students and to identify the needs of the students and all stakeholders, the University of Naples Federico II uses the Quality Assurance (QA)<sup>23</sup> System, developed in accordance with the document "Self-evaluation, Evaluation and Accreditation of the Italian University System" of ANVUR, using:
  - surveys on the degree of placement of graduates into the world of work and on postgraduate needs;
  - data extracted from the administration of the questionnaire to assess student satisfaction for each course in the curriculum, with questions relating to the way the course is conducted, teaching materials, teaching aids, organisation, facilities.

The requirements deriving from the analysis of student satisfaction data, discussed, and analysed by the Teaching Coordination Committee and the Joint Teachers' and Students' Committee (CPDS), are included among the input data in the service design process and/or among the quality objectives.

3. The QA System developed by the University implements a process of continuous improvement of the objectives and of the appropriate tools to achieve them, ensuring that planning, monitoring, and self-assessment processes are activated in all the structures to allow the prompt detection of problems, their adequate investigation, and the design of possible solutions.

# Article 21 Final Rules

The Department Council, on the CCD's proposal, submits any proposals to amend and/or supplement these Rules for consideration by the Academic Senate.

# Contents of the Activities consistent with the educational objectives of the course:

The final examination for the Master's Degree consists of the discussion of a thesis on topics related to the subject areas characterising the Master's Degree Course and consistent with the general objectives of the Degree Class.

# **Educational objectives:**

The thesis is written by the candidate in an original manner under the guidance of a lecturer/speaker, it must show that the candidate has been able to set up and conduct a research activity in one of the disciplines taught in the course by demonstrating attained cultural maturity and solid critical competence and obtaining a research result with an original character.

# Input propaedeuticities:

Accessible after having obtained the **96** CFUs foreseen by the Course of Study. (120 CFU minus 24 for the final examination)

## Type of profit assessment tests:

The final assessment will be determined by the committee from the sum of the mark obtained from the discussion of the thesis (which must take into account the quality of the work and the quality of the public discussion) with the average achieved in the profit examinations translated into one hundredth of a second.

The degree may be awarded with distinction provided that the committee is unanimous in awarding it.
