Art. 1 Object

1. This Regulation governs the organizational aspects of the Degree Course in Archaeology, History of Arts and Science of Cultural Heritage, Archaeology, History of Arts and Science of Artistic Heritage, class L-1 Cultural Heritage. The Degree Course in Archaeology, History of Arts and Science of Cultural Heritage is part of the Department of Humanistic Studies.

2. The Degree Course is governed by the Teaching Coordination Commission, pursuant to Art. 4 of the RDA, chaired by a Coordinator elected by the Department Council, among the full-time tenured professors responsible for a course in the same Degree Course. It includes all professors, including contract professors, researchers responsible for a course in the Degree Course, even if not affiliated with the Department, representatives of the Degree Course students elected to the Department Council, enrolled in the course itself.

The Degree Course Coordination Committee may establish, where necessary, one or more sub-commissions, to which it may delegate specific instructional tasks (art. 4, paragraph 4 of the RDA).

The Degree Course in Archaeology, History of Arts and Cultural Heritage Sciences is divided into four curricula

with a very solid common basis in the main humanistic subjects provided for by the ministerial card. It aims to train graduates who are familiar with the heritage of cultural heritage, considered in its diachronic path, from antiquity to the contemporary age, and in its various values (methodological,

historical, material, formal, content-related, conservative and managerial). In particular, graduates must be equipped with:

- an adequate spectrum of historical-philological knowledge in the sectors of archaeological, historical-artistic, economic-managerial, musical and entertainment heritage, based on the curriculum chosen upon enrolment;
- an adequate general cultural education in the field of the humanities, with particular attention to the history and development of Italian and ancient literature, based on the use of up-to-date teaching and bibliographical tools.

Graduates, furthermore, will have to acquire the ability to analyze and interpret phenomena, as well as communication skills in their presentation, discussion and valorization.

The Course of Study provides a suitable number of credits for internships and *placements*, with professionalizing purposes, at local authorities, public institutions, professional organizations operating in the sector of protection, conservation and enhancement of cultural heritage.

The graduate in Archaeology, History of Arts and Cultural Heritage Sciences must have a reasonable knowledge of at least one European Union language, in addition to Italian, and must be able to use the main IT tools for data management and telematic communication in the specific areas of expertise.

The teaching activity will be divided into lectures, exercises, laboratories, seminars, site visits and guided tours of museums, churches, archaeological sites, in addition to individual study.

Assessment tools: exams, any tests in progress, student reports at the end of seminar and laboratory activities.

Graduates in Archaeology, History of Arts and Cultural Heritage Sciences, based on the knowledge acquired in their field of study, must be able to:

- research and critically use literary and documentary sources;
- provide a detailed diachronic reconstruction of events and problems, grasping their connections with other historical-cultural areas;
- evaluate cultural heritage phenomena in relation to the most up-to-date historiographical reflection.

(3.4.4.2.1) Museum technicians

Function in a work context

They prepare, organize and arrange models and specimens, such as fossils, tools, objects of various kinds, artistic artefacts, for exhibitions and museum events; they catalogue objects and works of art.

Skills associated with the function

They have a good basic education and an adequate range of knowledge in the various sectors – archaeological, historical-artistic, archives and books, theatre, music, cinema, environment and landscape, as well as adequate skills in relation to legislation and administration of cultural heritage. They use the main IT and telematic communication tools in the specific areas of expertise. They are able to communicate the knowledge acquired to specialists and non-specialists. They use correctly

at least one language of the European Union, in addition to Italian, with reference also to disciplinary lexicons.

Career opportunities

At local authorities and specific institutions, such as superintendencies, museums, libraries, archives, film libraries, natural parks.

(3.3.1.1.2) Archive and library assistants

Function in a work context

They deal competently with archive documents and appreciate and valorize books, both ancient and modern, because they know the production techniques and not only the material.

Skills associated with the function

They have a good knowledge of the book and the document, both as objects (containers) and as carriers of information (contents), from which derives the ability to reconstruct the production contexts.

Career opportunities

Assistants in public and private libraries and archives.

(3.3.3.3.1) Auctioneers and successful bidders

Function in a work context

They are able to organize an auction, with the research, selection and cataloguing of the goods to be sold, the execution of the administrative procedures, the order of presentation of the objects, the criteria and methods of acquisition, the awarding of the goods put up for auction.

Skills associated with the function

They have a solid knowledge of the Italian language, knowledge in the historical-artistic and library fields and in the field of legislation relating to cultural heritage.

Career opportunities

Auctioneer, auction broker.

(3.4.3.2.0) Radio, television, film and theatre production organisation technicians

Function in a work context

They prepare reports or notes on work done or to be done, supervise the assembly of programs, organize work or activities, provide technical assistance.

Skills associated with the function

They possess knowledge of the Italian language, of historical events, of their causes and effects on civilizations and cultures, of geography, of the arts, of the principles and methods that regulate business and its management, of legislation.

Career opportunities

Cinema and TV stage assistant, production secretary.

Function in a work context

They are able to organize or manage tourism marketing actions, organize events to promote and develop tourism, collect and analyze statistical data on tourist flows, manage financial resources, plan and organize tourism activities, carry out administrative activities.

They have knowledge of the Italian language, a foreign language, history and archaeology, geography, arts, laws and regulations, principles and methods that govern the company and its management relating to strategic planning and the allocation of human, financial and material resources.

Art. 4

Admission requirements and knowledge required for access to the Course of Study¹

To be admitted to the Degree Course in Archaeology, History of Arts and Cultural Heritage Sciences, students must have a high school diploma or another qualification obtained abroad, recognized as suitable.

The knowledge required for access is:

- a) basic notions of Western history;
- b) basic notions of the history of Italian literature;
- c) a fair knowledge, written and oral, of one of the following modern languages: English, French, German, Spanish.

Furthermore, a good knowledge of the Italian language in written and oral form, the ability to analyze, summarize, paraphrase and critically comment on the texts given for reading, as well as basic notions of general culture, as required by the completion of the secondary school studies, are required.

Art. 5 Access to the Course of Study

Enrolled students will have to take an assessment test, also online, the outcome of which is not binding for enrollment purposes, with the aim of providing general information on the aptitude to undertake the chosen studies and on the state of basic knowledge. For the verification of linguistic knowledge and for any recovery actions, the Degree Course may also avail itself of the collaboration of the University Language Center, in person or online.

In the event of a negative assessment of the adequate initial preparation described through the indication of the knowledge required for access to the Degree Course, the Teaching Coordination Commission assigns specific Additional Training Obligations (OFA) indicating the assessment methods to be satisfied within the first year of the course and, if necessary, recovery.

Art. 6 Educational activities and university training credits

Each training activity prescribed by the CdS regulations is measured in university training credits (CFU). Each CFU conventionally corresponds to 25 hours of work per student and includes the hours of assisted teaching and the hours reserved for personal study or other individual training activities. For the course of study covered by this Regulation, the hours of assisted teaching for each CFU, established in relation to the type of training activity, are the following:

frontal lesson: 5 hours per CFU;exercises: 5 hours per CFU.

internship: 25 hours per CFU at the Institution;

The CFU corresponding to each training activity are acquired by the student by satisfying the verification methods (exam, suitability or attendance) indicated in the sheet relating to the teaching.

Art. 7 Articulation of teaching methods

The teaching activity is carried out in the following modalities:

a. Conventional study course.

The CCD decides which courses also include online teaching activities.

Some courses may include classroom or field exercises and laboratories.

Detailed information on how each course is taught can be found on the course sheets.

Art. 8 Verification tests for training activities²

- 1. The Teaching Coordination Commission, within the regulatory limits provided³, establishes the number of exams and other methods of evaluation of the profit that determine the acquisition of university training credits. The exams are individual and can consist of written, oral, practical, graphic tests, essays, interviews or combinations of these methods.
- 2. The methods of carrying out the tests published in the teaching sheets and the exam calendar will be made known to students before the start of lessons on the Department website.
- 3. The taking of exams is subject to the relative reservation that takes place electronically. If the student has not been able to proceed with the reservation for reasons that the President of the Commission considers justified, the student may still be admitted to the exam, at the end of the other students who have booked.
- 4. Before the exam, the President of the Commission verifies the identity of the student, who is required to show a valid identification document with a photograph.
- 5. The evaluation of the exams is expressed in thirtieths, or with a judgment of suitability. The exams that require an evaluation in thirtieths are passed with the minimum vote of eighteen thirtieths; the vote of thirty thirtieths can be accompanied by honors by unanimous vote of the Commission.

- 6. The oral exam tests are public, in compliance with the current safety regulations. If written tests are foreseen, the candidate has the right to view his/her own paper/papers after correction.
- 7. The examination commissions are governed by the University Teaching Regulations.

Art. 9 Course structure and study plan

- 1. The legal duration of the Course of Study is 3 years. It is also possible to enroll on the basis of a contract according to the rules set by the University (Art. 21 of the RDA).
 - The student will have to acquire 180 **CFU**, attributable to the following **Types** of Training Activities (TAF):
 - A) basic,
 - B) characterizing,
 - C) similar or complementary,
 - **D**) at the student's choice,
 - **E**) for the final exam and verification of knowledge of at least one foreign language other than Italian,
 - **F**) further training activities.
- 2. The degree is obtained after having acquired 180 CFU by passing the exams, in number of 16, and by carrying out other training activities.
 - Unless otherwise provided by the legal system of university studies, for the purposes of counting, exams taken within the scope of basic, characterizing and similar or integrative activities as well as within the scope of activities autonomously chosen by the student (TAF **D**, counted as one)⁴ are considered. Tests that constitute an assessment of suitability in relation to the activities referred to in Art. 10 paragraph 5 letters c), d) and e) of Ministerial Decree 270/2004 are excluded from the count⁵.
 - To acquire the CFU related to the activities of independent choice, the student has the freedom to choose among all the courses activated at the University, provided that they are consistent with the training project. This consistency is assessed by the Teaching Coordination Commission of the Degree Course. Also for the acquisition of the CFU related to the activities of independent choice, it is required to "pass the exam or another form of assessment of the profit" (Art. 5, c. 4 of the Ministerial Decree 270/2004).
- 3. The study plan summarizes the structure of the course by listing the planned courses divided by year of the course and by curriculum. There are no prerequisites. The study plan offered to students, with the indication of the scientific-disciplinary sectors and the area of affiliation, the credits, the type of teaching activity is reported in the **Attachment 1** to this regulation.

Art. 10 Attendance requirements⁶

1. In general, attendance at lectures is strongly recommended but not mandatory.

- 2. If the teacher foresees a different modulation of the program for attending and non-attending students, this will be specifically indicated in the individual teaching sheet published on the course web page.
- 3. Attendance at seminar activities that award training credits is mandatory. The relative methods for awarding CFU are the responsibility of the CCD.

Art. 11 Propaedeutics

Any prerequisites and prior knowledge deemed necessary are indicated in the teaching sheet.

Art. 12 Course calendar

The course calendar is made available on the Department website before the start of lessons.

Art. 13 Criteria for recognition of credits acquired in other courses of study of the same class⁷

For students coming from Courses of Study of the same class, the Teaching Coordination Commission ensures the recognition of the greatest possible number of university training credits acquired by the student at the course of study of origin, according to the criteria set out in the following article 14. Failure to recognize university training credits must be adequately motivated. It remains understood that the quota of university training credits relating to the same scientific-disciplinary sector directly recognized to the student cannot be less than 50% of those already obtained.

Art. 14

Criteria for recognition of credits acquired in Courses of Study of different classes, through single courses, at telematic universities and in international Courses of Study⁸

- 1. For students coming from courses of study of different classes, the university training credits acquired are recognized by the competent teaching structure on the basis of the following criteria:
 - Analysis of the program carried out;
 - Evaluation of the congruence of the scientific-disciplinary sectors and the contents of the training activities in which the student has acquired credits with the specific training

objectives of the course of study and of the individual training activities to be recognized, while still pursuing the purpose of student mobility.

Recognition is carried out up to the amount of university training credits provided for by the educational regulations of the course of study. Failure to recognize university training credits must be adequately motivated.

2. Any recognition of CFU relating to exams passed as single courses may occur within the limit of 36 CFU, at the request of the interested party and following approval by the competent teaching structures. The recognition may not contribute to the reduction of the legal duration of the course of study, as determined by Art. 8, c. 2 of Ministerial Decree 270/2004, with the exception of students who enroll while already in possession of a qualification of the same level⁹.

Art. 15 Criteria for enrollment in single teaching courses activated within the Study Courses

Enrolment in individual courses, provided for by the University Regulations¹⁰, is governed by the University Regulations for enrolment in individual courses activated within the Degree Courses ¹¹.

Art. 16 Characteristics and methods of carrying out the final exam

Characteristics of the final exam

The final exam for the achievement of the degree consists of the public discussion of a written paper, before a commission, in compliance with the provisions of the University Teaching Regulations. This paper, written under the guidance of a tutor teacher, must demonstrate that the candidate has been able to conduct research in one of the subjects taught in the course, taking into account the relevant bibliography.

The procedures, deadlines and administrative procedures for the assignment and submission of the thesis and for admission to the final exam for the achievement of the degree are made known by the teaching structures and the Department of Humanistic Studies through the appropriate forms of advertising provided for by the University Regulations.

The final evaluation will be determined by the commission by adding the average obtained in the profit exams, translated into one hundred and tenth, and the score assigned by the degree exam commission (maximum 11 points).

The grade for the final exam is expressed in one hundred and tenth, with possible honors, pursuant to art. 11, paragraph 7, letter e) of Ministerial Decree 270/2004.

Art. 17 Guidelines for Internship and Stage Activities

- 1. Students enrolled in the Degree Course can decide to carry out internships or training internships, at institutions or companies affiliated with the University or even in *intra moenia* mode. Internship and stage activities are mandatory, and contribute to the attribution of training credits for the other training activities chosen by the student included in the study plan, as provided for by Art. 10, paragraph 5, letters d and of the Ministerial Decree 270/2004.
- 2. The methods of implementation and the characteristics of internships and stage are regulated by the CCD in a specific regulation.
- 3. The University of Naples Federico II, through the Internship Office, ensures constant contact with the world of work, to offer students and graduates of the University concrete opportunities for internships and *work placements* and to facilitate their professional integration.

Art. 18 Loss of student status¹²

A student who has not taken exams for eight consecutive academic years incurs forfeiture, unless his/her contract establishes different conditions. In any case, the forfeiture must be communicated to the student by certified e-mail or other suitable means that attests to its receipt.

Art. 19 Teaching tasks, including supplementary teaching, orientation and tutoring activities

- 1. Professors and researchers carry out the assigned teaching load in accordance with the provisions of the University Teaching Regulations and the Regulations on teaching and student service duties of professors and researchers and on the methods for self-certification and verification of actual performance¹³.
- 2. Teachers and researchers must guarantee at least two hours of reception every 15 days (or by appointment in any case granted no later than 15 days) and in any case guarantee availability via email.
- 3. The tutoring service has the task of orienting and assisting students throughout their studies and of removing obstacles that prevent them from deriving adequate benefit from attending courses, also through initiatives related to the needs and aptitudes of individuals.
- 4. The University provides guidance, tutoring and assistance services and activities for the reception and support of students. These activities are organized by the Guidance Service in collaboration with the individual Teaching Structures, as established by the RDA in article 8.

Art. 20 Evaluation of the quality of the activities carried out

- 1. The Teaching Coordination Commission implements all forms of quality assessment of teaching activities required by current legislation according to the indications provided by the University Quality Assurance Board.
- 2. In order to guarantee the students of the Degree Course the quality of teaching and to identify the needs of students and all interested parties, the University of Naples Federico II uses the Quality Assurance (QA) system¹⁴, developed in compliance with the document "Self-evaluation, Evaluation and Accreditation of the Italian University System" of the ANVUR, using:
 - surveys on the degree of integration of graduates into the world of work and on postgraduate needs;
 - data extracted from the administration of the questionnaire for the evaluation of student satisfaction for each course present in the study plan, with questions relating to the methods of carrying out the course, the teaching material, the teaching aids, the organization, the structures.

The requirements resulting from the analysis of student satisfaction data, discussed and analyzed by the Teaching Coordination Commission and the Joint Teacher-Student Commission (CPDS), are included among the input data in the service design process and/or among the quality objectives.

3. The QA organization developed by the University implements a process of continuous improvement of the objectives and the appropriate tools to achieve them, ensuring that in all structures planning, monitoring and self-assessment processes are activated that allow for the prompt detection of problems, their adequate investigation and the setting of possible solutions.

Art. 21 **Final provisions**

1. The Department Council, upon proposal of the Teaching Coordination Commission, submits any proposals for modification and/or integration of these Regulations to the Academic Senate for examination.

Art. 22 **Publicity and entry into force**

- 1. This Regulation enters into force the day after its publication on the Official Notice Board of the University; it is also published on the University website.
 - The same forms and methods of advertising are used for subsequent amendments and additions.
- 2. **Annex 1** and **Annex 2** are an integral part of this Regulation.
