## Art. 1

### Object

1. These Didactic Regulations govern the organisational aspects of the CdSM in Management of Cultural Heritage (class LM-76). The CdSM in Management of Cultural Heritage is hinged in University of Naples "Federico II", Department of Humanities.

*CdSM name in English:* Cultural Heritage Management

*CdSM name in Italian:* Management del Patrimonio Culturale

*Class:* LM-76 Economic Science for Environment and Culture

*Teaching language:* Italian

*Course delivery methods:* conventional

2. The CdSM is governed by the Didactic Coordination Commission (CCD), pursuant to Art. 4 of the RDA.
  - In accordance with article 4, comma 4, lett. l of the RDA, the CCD has established a subcommittee with regard to the responsibilities indicated in the same article 4, comma 4, lett. b), c), d) (curricula, student practices, foreign degrees).
  - In accordance with Article 4, comma 4, lett. e) of the RDA, the CCD has established a Review Group (GRIE) for periodic monitoring and evaluation procedures.
3. The Didactic Regulations are issued in compliance with the relevant legislation in force, the Statute of the University of Naples Federico II, and the RDA.

## Art. 2

### Training objectives

The Master's Degree Course in 'Management of Cultural Heritage' - incardinato in the degree class LM-76 'Economic Sciences for the Environment and Culture' - aims at training professionals with a solid managerial preparation for the valorisation and management of cultural heritage in an innovative, inclusive and sustainable perspective.

The course of study is based on the integration of cultural and environmental disciplines - essential for understanding cultural heritage and its value in the contexts of reference - and economic, economic-managerial, statistical and legal disciplines. In fact, the aim of the degree is to promote high-profile knowledge and skills for a cultural heritage management that has a positive impact on territories and communities, without altering their landscape and identity qualities.

As far as job opportunities are concerned, graduates of the 'Cultural Heritage Management' degree course will be able to take on functions of high responsibility both in the public sector (superintendencies, museums, libraries, local administrations and authorities, higher education institutions) and in the private sector (foundations, cultural associations and institutes, galleries and auction houses, cultural organisations and enterprises), meeting the needs of the 'culture' sector and of today's working contexts. In the area of job opportunities, the degree course not only promotes training for roles in public institutions or private enterprises, but also supports entrepreneurship in the cultural sector through the acquisition of knowledge and skills for 'business creation'.

The knowledge and skills acquired in the economic, economic-managerial, statistical and legal spheres by undergraduates in 'Cultural Heritage Management' may also allow access to specialisation schools, Level I and II masters courses, and PhDs focusing on the enhancement and management of cultural heritage. The competitive, sustainable and inclusive management of the cultural and environmental heritage requires the acquisition of knowledge and theoretical-applicative skills that are able to respond to the different needs of the contexts, to trigger redevelopment processes and new opportunities for employment growth.

The presence of teachings related to the scientific-disciplinary sectors envisaged in the field of environmental and cultural disciplines - both in the area of characterising teachings and in the area of related and supplementary teachings - allows students to outline a training pathway in which managerial skills are calibrated and further enhanced in relation to their sphere of interest, which can range from the management of archaeological and historical-artistic heritage, to the management of library and photographic heritage, to the management of demo-ethno-anthropological, dramaturgical and musical heritage.

The specific educational objectives of the CdS magistrale in 'Management of Cultural Heritage', promoted through an innovative and interdisciplinary course of study, declines and specifies those of the LM-76 class 'Economic Sciences for Environment and Culture'. These are summarised in the attainment of scientific, theoretical, methodological knowledge and operational skills for an efficient management and valorisation of the cultural heritage with respect to economic, social and environmental sustainability.

Specific training objectives are:

- to be able to combine, in a multidisciplinary and integrated perspective, the knowledge and skills acquired in the economic, economic-managerial, statistical and legal disciplines with the knowledge and skills acquired through the cultural and environmental disciplines
- to acquire theoretical, methodological and operational knowledge and skills to analyse, design and manage decision-making processes aimed at the valorisation of heritage and cultural activities;
- being able to identify cultural resources capable of promoting processes of urban regeneration or reduction of territorial marginality through the involvement of stakeholders and local communities;
- being able to manage in a position of responsibility public and private institutions, protection bodies, public offices and foundations, enterprises and associations aimed at the promotion and enhancement of tangible and intangible cultural heritage;
- possessing knowledge and skills capable of creating cultural enterprises from scratch to promote local development and employment growth in a sustainable, inclusive, innovative perspective.

In line with the flexibility and customisation of courses, which is one of the innovative teaching methods included in the University's Strategic Plan, students are offered the possibility of constructing their own study plan by identifying an educational pathway that envisages, also within the framework of characterising courses, the possibility of choosing from among the SSDs envisaged in the disciplinary fields indicated by Ministerial Decree 1649/2023 for the LM-76 'Economics for the Environment and Culture' degree class.

Apprenticeships are an integral part of the didactic project and are activated with external partners of national and international importance, helping to consolidate the theoretical-applicative knowledge acquired by the students during the lectures. Graduates will be able to find employment opportunities as cultural site managers or event promoters in public/private organisations operating in different fields (archaeology, art, books, music, environment, multimedia, tourism).

The training and orientation internship activities further reinforce the experiential approach, as well as offering students the opportunity to start a thesis project in collaboration with the host institutions, and to establish personal and direct relationships that can be continued with further collaborations after graduation.

The Master's Degree in 'Cultural Heritage Management' is a two-year course comprising twelve examinations, including the final examination. The teaching load, expressed in terms of cfu, is equally divided between the first year and the second year. In order to obtain the degree, the student must acquire the 120 credits envisaged by the Ordinance.

The educational programme is finalised annually by the Commission for Educational Coordination of the Degree Course, which checks the consistency with the objectives described and the congruence of the contents in relation to the credits allocated, the educational goals of the LM-76 degree class and the Degree Course.

Teaching is structured in two semesters per year. In the first year the student must pass 6 examinations for a total of 60 cfu. In the second year the student must pass 6 examinations (including the final exam) for a total of 54 cfu, to which must be added an internship, additional language knowledge, other knowledge useful for entering the world of work for a total of 60 cfu. In order to obtain the master's degree, the student must have acquired 120 university credits, including those relating to the final examination.

Knowledge useful for integration into the world of work promotes the acquisition of transversal skills. Additional language knowledge provides for the acquisition of skills in the main European languages. The teaching method of the degree course is conventional; the teaching activities include lectures and tutorials.

More specifically, the study plan of the Master's Degree Course in 'Cultural Heritage Management' provides for the following in the first year: 36 cfu for characterising subjects, 12 cfu for related and supplementary subjects and 12 cfu for students' choice of educational activities (Ministerial Decree 270/2004, Art. 10, paragraph 5, letter a) for a total of 6 examinations and 60 cfu.

The characterising teachings, corresponding to 4 examinations and 36 cfu, pertain to the fields of economics, business disciplines, mathematical-statistical disciplines and environmental and cultural disciplines.

Therefore, these lectures provided in the first year of the degree course provide the necessary framework for the topics that will be addressed and explored in depth during the course. In addition, these characterising courses provide students with the coordinates on which to base their choice of the next two courses: the related and supplementary course among those offered by the degree course and the course of their choice among all those offered by the University, provided that it is consistent with the student's training pathway and the degree course objectives, also with a view to interdisciplinarity and flexibility.

A total of 60 cfu is to be acquired during the second year, divided between characterising lectures, final examination and other educational activities. Two 12 cfu courses will focus on managerial aspects, in line with the educational objectives and aims of the LM-76 degree class and the degree programme.

One 6 cfu teaching is envisaged in the area of legal disciplines, followed by two 6 cfu examinations in the area of environmental and cultural disciplines.

The second year envisages the acquisition of 6 cfu within the scope of the training activities identified by Article 10, paragraph 5, letter d of Ministerial Decree 270/2004, i.e.: training and

orientation apprenticeships, additional language knowledge, other knowledge useful for employment.

The course concludes with the final examination (Ministerial Decree 270/2004, Art. 10, subsection 5, letter c) which, with the acquisition of a further 12 cfu, determines the attainment of the 120 cfu envisaged and the award of the Laurea magistrale in 'Management of the Cultural Heritage'.

Enhancing and managing cultural heritage and the landscape, promoting cultural events and activities are, in fact, strategic objectives for socio-economic development while respecting identities and communities.

Cultural and environmental heritage, while always at the centre of the training process, are analysed according to different but complementary and integrated disciplinary perspectives; it is precisely this mix of skills (historical-artistic, economic-managerial, legal and socio-territorial) that allows the training of an innovative profile of 'Cultural Heritage Manager', aware of cultural values and able to enhance them in a smart, green and inclusive perspective.

### Art. 3

#### Professional profile and work opportunities

##### (2.5.1.3.1) - Specialist in Human Resources Management for Cultural Enterprises

###### **Role in a working context:**

The professions included in this unit deal with the selection and recruitment of the necessary personnel, define the criteria and programs for the development of careers, compensation and investments in training within organizations operating within the cultural and environmental sector.

###### **Skills related to the role in working contexts:**

The Master's Degree Program completes the skills necessary to carry out the functions of a specialist in human resources.

The graduate in Cultural Heritage Management, in consideration of the training course that will follow, will be able to understand the processes of planning and personnel management within the more general management strategy of cultural and environmental organizations. The skills acquired will allow him to carry out personnel management activities in a qualified manner.

In particular, graduates will possess:

- in-depth knowledge of the characteristics of the economy of art, legislation and management of cultural and environmental enterprises;
- understanding and knowledge of the organizational characteristics of cultural and environmental enterprises;
- knowledge of personnel management policies with particular reference to the cultural and environmental heritage sector;
- basic training in the humanities and art history.

###### **Employment opportunities:**

Employees in the personnel department of companies operating in the cultural and environmental sector, in employment agencies specialized in the sector.

##### (2.5.1.3.2) Specialists in the employers' organisation of Cultural Enterprises

###### **Role in a working context:**

The professions included in this Professional Unit study and analyse the methods of work organisation, identify the quantitative and qualitative needs of personnel and training of companies operating in the cultural and environmental sector.

**Skills related to the role in working contexts:**

The Master's Degree Program completes the skills necessary to carry out the functions of a specialist in the organisation of work, the learning of which began during the three-year period of the Master's Degree Program.

The graduate master's degree in Management of Cultural Heritage, in consideration of the training course that will follow, will be able to understand the processes of work organization within the more general management strategy of cultural and environmental organizations. The skills acquired will allow him to carry out personnel management activities in a qualified manner.

In particular, graduates will possess:

- in-depth knowledge of the characteristics of the art economy and the management of cultural and environmental enterprises;
- understanding and knowledge of the organizational characteristics of cultural and environmental enterprises;
- knowledge of personnel management policies with particular reference to the cultural and environmental heritage sector.
- basic training in the humanities and art history.

**Employment opportunities:**

Employees in the personnel department of companies operating in the cultural and environmental sector, in employment agencies specialized in the sector.

#### **(2.5.1.5.2) Specialists in marketing of cultural heritage and services**

**Role in a working context:**

The professions included in this unit are concerned with the implementation of sales strategies, efficiency of the distribution and sales network, sales monitoring and market acceptance of goods or services produced by organizations operating in the cultural and environmental sector, both public and private.

**Skills related to the role in working contexts:**

The Master's Degree completes the skills necessary to perform the functions of a specialist in the marketing of goods and services, the learning of which began during the three-year course of study. The master's master's degree graduate, in Cultural Heritage Management in view of the training course he or she will follow, will be able to understand the marketing and commercialization processes of cultural and environmental organizations. In particular, the skills acquired will enable him/her to perform in a qualified manner the activities related to the commercial management of public and private organizations operating in this sector.

Specifically, the graduate will possess:

- in-depth knowledge of characteristics to the economics of art, geography of tourism and management of cultural and environmental enterprises;
- understanding and knowledge of the marketing activities of cultural and environmental enterprises;
- knowledge of the business policies of organizations with special reference to the cultural and environmental heritage sector;
- basic knowledge in statistics;
- basic training in humanities and art history.

**Employment opportunities:**

Employees in the marketing and sales function of companies operating in the cultural and environmental sectors.

#### **(2.5.1.5.4) Marketing analysts in cultural sector**

##### **Role in a working context:**

Professions included in this unit conduct research on market conditions at different territorial levels to identify the possibilities for commercial penetration of products or services; they identify their competitive situations, prices, and sales and distribution methods.

##### **Skills related to the role in working contexts:**

The Master's Degree completes the skills necessary to perform the functions of a market analyst, the learning of which began during the three-year course of study.

The master's degree graduate, in Cultural Heritage Management in view of the training course he or she will follow, will be able to understand the processes of strategic marketing and market analysis for cultural and environmental organizations.

In particular, the skills acquired will enable him/her to perform in a qualified manner the activities related to market analysis for public and private organizations operating in this sector.

Specifically, the master's graduate will possess:

- in-depth knowledge of the characteristics to the economics of art, the geography of tourism and the management of cultural and environmental enterprises;
- understanding and knowledge of marketing activities of cultural and environmental enterprises;
- knowledge of market analysis techniques of organizations with special reference to the cultural and environment heritage sector;
- basic knowledge in statistics;
- basic training in humanities and art history.

##### **Employment opportunities:**

Employees in the marketing function of public and private companies and organizations operating in the cultural and environmental sector. Consulting and cultural events enterprises.

#### **(2.5.1.6.0) Specialists in communication and social media marketing**

##### **Role in a working context:**

The professions included in this unit promote the public relations and image of a company or organisation by writing texts, selecting and disseminating favourable publicity material, organising and sponsoring events of particular importance and visibility, charitable activities for the benefit of the population and similar activities not directly related to advertising promotion.

##### **Skills related to the role in working contexts:**

The Master's Degree graduate in Management of Cultural Heritage, in view of the training course he/she will follow, will be able to understand the online and offline communication processes of cultural and environmental organisations. In particular, the skills acquired will enable him/her to perform in a qualified manner the activities related to the promotion and communication of public and private organisations operating in the cultural sector.

In particular, the master's degree holder will possess:

- in-depth knowledge of the characteristics of the economics of art, the geography of tourism and the management of cultural and environmental enterprises;
- understanding and knowledge of the marketing activities of cultural and environmental enterprises;

- knowledge of market analysis techniques of organisations with special reference to the cultural and environmental heritage sector;
- basic knowledge in the field of statistics;
- basic training in the humanities and art history.

**Employment opportunities:**

Employees in the marketing function of public and private companies and organisations operating in the culture and environment sector. Consultancy and cultural events companies.

#### **(2.5.5.2.3) Artistic directors and experts in organizing cultural events**

**Role in a working context:**

The professions included in this unit plan, organize, direct and curate public representations, seasons, reviews, festivals and artistic performances, according to certain content, choices and artistic-cultural lines; they indicate protagonists, characteristics, themes and modes of performance.

**Skills related to the role in working contexts:**

The master's degree graduate, in Management of Cultural Heritage in view of the training course that will follow, will be able to coordinate, organize and direct event projects.

In particular, the skills acquired will enable him to perform in a qualified manner the activity related to the 'identification of the contents of the choices of the artistic-cultural lines and paths by indicating protagonists, characteristics, themes and methods of performance.

Specifically, the master's graduate will possess:

- economic-organizational-managerial knowledge
- artistic knowledge;
- legal knowledge;
- human resource management and development of new professionalism;
- technological and computer knowledge;
- basic training in humanities and art history.

**Employment opportunities:**

Artistic director (in various sectors) and employee of performing arts organizations.

#### **(2.6.5.3.2) Experts in educational activities in the cultural sector**

**Role in a working context:**

Professions included in this unit coordinate and design educational and curricular activities in dedicated training centers or directly in businesses and organizations.

**Skills related to the role in working contexts:**

The graduate of the Master's Degree program in Management of Cultural Heritage will develop communication skills capable of conveying, clearly and unequivocally, ideas, problems, knowledge and solutions in both technically identified contexts and broader contexts referring to even non-specialist users. The disciplines envisaged within the training course tend to increase awareness of linguistic processes and mastery of the linguistic-communicative tool. All this will enable them to deal with every aspect of the problems related to the professionalism in question, to understand its complexity and envisage solutions; it will also provide the ability to learn the knowledge-base and methodology for the acquisition of relevant knowledge, the capitalization of acquisitions for future purposes (flexibility, reversibility, transferability of the training experience); professional skills and together communicational and relational skills; ability to self-evaluate and evaluate for professional



purposes; ability to understand and analyze linguistic texts and processes, including in the context of intercultural issues.

**Employment opportunities:**

Public and private training and research centers.

## **Art. 4**

### **Admission requirements and knowledge required for access to the Master's Degree Program<sup>1</sup>**

In order to enroll in the Master's Degree Course in Cultural Heritage Management it is necessary to:

1. Having a degree in Cultural Heritage (L-1), Visual Arts, Music, Performing Arts and Fashion (L-3), Philosophy (L-5), Literature (L-10), Modern Languages and Cultures (L-11), Tourism Sciences (L-15), Economics and Business Management (L-18), History (L-42) in accordance with Ministerial Decree 270/04 or a corresponding degree in accordance with previous regulations (Ministerial Decree 509/99 and Law 508/99) obtained from an Italian university.

2. Having achieved the following minimum curricular requirements

Students who have obtained first-level academic degrees from AFAM (Higher Education in Art, Music, and Dance) Institutions may also enroll. In any case, students must have met the following minimum curricular requirements:

- a minimum of **18 CFUs (credits)** in the linguistic, literary, historical and philosophical disciplines.
- a minimum of **36 CFUs (credits)** in the archeological, historical-art, environmental, social and juridical disciplines.
- a minimum of **12 CFUs (credits)** in the economic, business and statistics disciplines.

**B1** level knowledge in one of the main European languages (English, French, Spanish, German) according to the Common European Framework of Reference for Languages (**CEFR**).

Each application will be evaluated by the Teaching Committee of the Master's Degree Program in Cultural Heritage Management.

**Students who have obtained a degree abroad, equivalent to the three-year degrees indicated, may be admitted, taking into account the admission requirements and the guidelines of CIMEA (Center for Information on Mobility and Academic Equivalences, <https://www.cimea.it>). Each application will be evaluated on a case-by-case basis by the Teaching Committee of the Master's Degree Program in "Cultural Heritage Management."**

## Art. 5

### Procedures for access to the Master's Degree Program (CdSM)

1. The CCD of the Master's Degree Program normally regulates the admission criteria and any scheduling of enrolments, except in cases subject to different provisions of law<sup>2</sup>.
2. Verification of personal preparation is always mandatory, and only students who meet the curricular requirements can access it.
3. Students interested in enrolling, even if they do not yet hold a bachelor's degree, may submit an application to the Educational Coordination Committee in order to verify the presence of all the minimum requirements (18 CFUs in the linguistic, literary, historical and philosophical disciplines; 36 CFUs in the archaeological, historical-art, environmental, social and juridical disciplines; 12 CFUs in the economic, business and statistic disciplines; B1 level in the main European languages). Article 4 of the Teaching Regulations lists the SSD (Scientific Disciplinary Sectors) that fall under the three areas to which the credits for access refer. In this regard, please also refer to "Knowledge required for entry."

In the absence of the entry requirements, the Commission will inform students what deficiencies need to be filled and how. As for the credits related to the three fields, the missing credits can be acquired by enrolling in single courses active at all universities for the SSD corresponding to the linguistic, literary, historical and philosophical disciplines (18 CFU), the archaeological, historical-art, environmental, social and Juridical disciplines (36 CFU), the economic, business and statistic disciplines (12 CFU). The certification of passing one or more exams - equal to the missing CFUs - makes it possible to make up for this deficiency in entry.

Regarding the knowledge of one of the main European language's skills (English, French, Spanish, German) at the B1 level, this entry requirement may be certified (or self-certified in the case of

activities carried out at Italian state universities or other Italian public institutions) in one of the following ways:

- having acquired a total of 4 CFUs

in one of the scientific-disciplinary fields:

L-LIN/11, LIN/12 (English), L-LIN/04 (French), L-LIN/06 o L-LIN/07 (Spanish), L-LIN/14 (German)

scientific-disciplinary sectors according to D.M. (Ministerial Decree) n.639/2024:

ANGL-01/B o ANGL-01/C (English), FRAN-01/B (French), SPAN-01/B o SPAN-01/C (Spanish), GERM-01/C (German);

- knowledge of a foreign language - English - (Art. 10, Paragraph 5, Letter C) in the previous university course;
- have passed a B1-level exam at a University Language Center;
- possess one of the international certificates of one of the main European language's skills listed in the Accredited Entities list of the MUR;

*or be in one of the following conditions:*

- have completed a period of study abroad (Ex. Erasmus, Overseas or equivalent) at an English, French, Spanish, German speaking university;
- have completed an internship period of not less than 3 months in an English, French, Spanish, German -speaking country;
- have earned a bachelor's degree from an English, French, Spanish, German -speaking university;
- have earned the degree imparted entirely in English, French, Spanish, German;
- be a native English, French, Spanish, German speaker.

In the absence of suitable proof of English language proficiency of **B1** level, it will be necessary to pass a one of the main European languages (English, French, Spanish, German) test of B1 level. Students who do not have this requirement will have the opportunity to participate in placement test sessions to ascertain language knowledge/competency at the University Language Center.

For students with a degree obtained abroad, the evaluation of the entry requirements (compatibility of the degree with respect to the indicated Degree Classes, evaluation of the curriculum, credits and learning outcomes with respect to the foreseen competencies and SSDs) is carried out through the examination of the documentation produced by the student by the Educational Coordination Committee, which assesses the need for the student to take the interview to verify the student's knowledge of written and spoken Italian. The interview may also take place by telematics.

## **Art. 6**

### **Teaching activities and university training credit (Teaching activities and CFU)**

Each training activity, prescribed by the CdSM detail sheet, is measured in CFU.

Each CFU corresponds to 25 hours of overall training commitment<sup>3</sup> per student and includes the hours of teaching activities specified in the curriculum as well as the hours reserved for personal study or other individual training activities.

For the Master's Degree Program covered by this Didactic Regulations, the hours of teaching specified in the curriculum for each CFU, established in relation to the type of training activity, are as follows <sup>4</sup>:

- Lecture or guided teaching exercises: **5** hours per CFU;

For internship activities, each credit corresponds to **25** hours of overall training commitment <sup>5</sup>.

The CFU corresponding to each training activity acquired by the student is awarded by satisfying the assessment procedures (examination, pass mark) indicated in the Course sheet relating to the course/activity attached to these Didactic Regulations.

## **Art. 7** **Description of teaching methods**

The didactic activity is carried out in modality conventional<sup>6</sup>.

If necessary, the CCD decides which courses also include teaching activities offered online.

Detailed information on how each course is conducted can be found in the course sheets.

## **Art. 8** **Testing of training activities<sup>7</sup>**

1. The CCD, within the prescribed regulatory limits<sup>8</sup>, establishes the number of examinations and other means of assessment that determine the acquisition of credits. Examinations are individual

and may consist of written, oral, practical, graphical tests, term papers, interviews, or a combination of these modes.

2. The examination procedures published in the course sheets and the examination schedule will be made known to students before the start of classes on the Department's website.<sup>9</sup>
3. Examinations are held subject to booking, which is made electronically. In case the student is unable to book an exam for reasons that the President of the Board considers justifiable, the student may still be admitted to the examination, following those students already booked.
4. Before examination, the President of the Board of Examiners verifies the identity of the student, who must present a valid photo ID.
5. Examinations are marked out of 30. Examinations involving an assessment out of 30 shall be passed with a minimum mark of 18; a mark of 30 may be accompanied by honours by a unanimous vote of the Board. Examinations are marked out of 30 or with a simple pass mark. Assessments following tests other than examinations are marked out with a simple pass mark.
6. Oral exams are open to the public. If written tests are scheduled, the candidate has the right to see his/her paper(s) after correction.
7. The University Didactic Regulations govern Examination Boards<sup>10</sup>.

## **Art. 9**

### **Master's Degree Program structure and Study Plan**

1. The legal duration of the Master's Degree Program is 2 years.  
The student must acquire 120 CFU<sup>11</sup>, attributable to the following Types of Training Activities (TAF):
  - B)** characterising,
  - C)** related or complementary,
  - D)** at the student's choice<sup>12</sup>,
  - E)** for the final exam,
  - F)** further training activities.

2. The Master's Degree is awarded after having acquired 120 CFU by passing examinations, not exceeding 12, and the performance of other training activities<sup>13</sup>.

Unless otherwise provided for in the legal framework of University studies, examinations taken as part of basic, characterising, and related or supplementary activities, as well as activities chosen autonomously by the student (TAF D) are taken into consideration for counting purposes. Examinations or assessments relating to activities independently chosen by the student may be taken into account in the overall calculation corresponding to one unit<sup>14</sup>. Tests constituting an assessment of suitability for the activities referred to in Article 10, paragraph 5, letters d) and e) of Ministerial Decree 270/2004<sup>15</sup> are excluded from the count. Integrated Courses comprising of two or more modules are subject to a single examination.

3. In order to acquire the CFU relating to independent choice activities, the student is free to choose among all the Courses offered by the University, provided that they are consistent with the training project. This consistency is assessed by the Didactic Coordination Commission. Also, for the acquisition of the CFU relating to autonomous choice activities, the "passing the exam or other form of profit verification" is required (Art. 5, c. 4 of Ministerial Decree 270/2004).
4. The study plan summarises the structure of the Master's Degree Program, listing the envisaged teachings broken down by course year and, in case, by curriculum. At the end, the propedeuticities envisaged by the Master's Degree Program are listed (**Annex 1**). The study plan offered to students, with an indication of the scientific-disciplinary sectors and the area to which they belong, of the credits, of the type of educational activity, is set out in Annex 1 to these Didactic Regulations.
5. Pursuant to Art. 11, paragraph 4-bis, of Ministerial Decree 270/2004, it is possible to obtain the Master's Degree according to an individual study plan that also includes educational activities different from those specified in the Didactic Regulations, as long as they are consistent with the CdSM detail sheet of the academic year of enrollment. The individual study plan is approved by CCD.

## Art. 10 Attendance requirements<sup>16</sup>

1. In general, attendance of lectures is a) strongly recommended but not compulsory.

2. If the lecturer envisages a different syllabus modulation for attending and non-attending students, this is indicated in the individual Course details published on the CdSM web page and on the teacher's UniNA website.

### **Art. 11**

#### **Prerequisites and prior knowledge**

1. The list of incoming and outgoing propedeutics (necessary to sit a particular examination) can be found at the end of Annex 1 and in the teaching/activity course sheet (**Annex 2**).
2. Any prior knowledge deemed necessary is indicated in the individual Teaching Schedule published on the course webpage and on the teacher's UniNA website.

### **Art. 12**

#### **Master's Degree Program Calendar**

The Master's Degree Program calendar can be found on the Department's website (<https://www.studiumanistici.unina.it/>) well before the start of the activities (Art. 21, c. 5 of the RDA).

### **Art. 13**

#### **Criteria for the recognition of credits earned in other Master's Degree Programs in the same Class<sup>17</sup>**

For students coming from Master's Degree Programs of the same class, the Didactic Coordination Commission ensures the full recognition of CFU, when associated with activities that are culturally compatible with the training Master's Degree Program, acquired by the student at the originating Master's Degree Program, according to the criteria outlined in Article 14 below. Failure to recognise credits must be adequately justified. It is without prejudice to the fact that the number of credits relating to the same scientific-disciplinary sector directly recognised by the student may not be less than 50% of those previously achieved.

### **Article 14**

#### **Criteria for the recognition of credits acquired in Master's Degree Programs of different classes, in university or university-level Degree Programs, through single courses, at online Universities and in international Degree Programs<sup>18</sup>; criteria for the recognition of credits acquired in extra-curricular activities**

1. With regard to the criteria for the recognition of CFU acquired in Master's Degree Programs of different Classes, in university or university-level Degree Programs, through single courses, at online Universities and in International Degree Programs, the credits acquired are recognised by the CCD on the basis of the following criteria:

- analysis of the activities carried out;
- evaluation of the congruity of the disciplinary scientific sectors and of the contents of the training activities in which the student has earned credits with the specific training objectives of the Degree Program and of the individual training activities to be recognised.

Recognition is carried out up to the number of credits envisaged by the didactic system of the Degree Program. Failure to recognise credits must be adequately justified. Pursuant to Art. 5, c. 5-bis, of Ministerial Decree 270/2004, it is also possible to acquire CFU at other Italian universities on the basis of agreements established between the concerned institutions, in accordance with the regulations current at the time <sup>19</sup>.

2. Any recognition of CFU relating to examinations passed as single courses may take place within the limit of 36 CFU, upon request of the interested party and following the approval of the CCD. Recognition may not contribute to the reduction of the legal duration of the Degree Program, as determined by Art. 8, c. 2 of Ministerial Decree 270/2004, except for students who enrol while already in possession of a degree of the same level<sup>20</sup>.
3. With regard to the criteria for the recognition of CFU acquired in extra-curricular activities, pursuant to Art. 3, par. 2, of Ministerial Decree (D.M.) 931/2024, within the limit of 48 CFU (Bachelor's Degrees and single-cycle Master's Degrees), or 24 CFU (Master's Degrees), the following activities may be recognised (Art. 2 of D.M. 931/2024):
  - Professional knowledge and skills, certified in accordance with the current regulations as well as knowledge and skills acquired in post-secondary-level training activities.
  - Training activities carried out in the cycles of study at the public administration training institutions as well as knowledge and skills acquired in post-secondary-level training activities, which the University contributed to developing and implementing.
  - Achievement of an Olympic or Paralympic medal or the title of absolute world champion, absolute European champion or absolute Italian champion in disciplines recognized by the Italian National Olympic Committee or the Italian Paralympic Committee.

## **Art. 15**

### **Criteria for enrolment in individual teaching courses**

Enrolment in individual teaching courses, provided for by the University Didactic Regulations<sup>21</sup>, is governed by the "University Regulations for enrolment in individual teaching courses activated as part of the Degree Program"<sup>22</sup>.

## **Article 16**

### **Features and modalities for the final examination**

The master's degree in 'Management of Cultural Heritage' is obtained after passing a final examination, consisting in the discussion of an original work (thesis of a critical and/or project nature) on topics carried out within the framework of the Master's Degree Course and consistent with the educational objectives of the LM-76 'Economic Sciences for the Environment and Culture' degree class.

The thesis is carried out under the guidance of one or more lecturers to provide the student with support in identifying the topic, in the study and research activities, in the elaboration of the text, in the preparation of the presentation and discussion for the degree examination.

In the final examination the undergraduate student must demonstrate that he/she:

- having elaborated one's thesis with originality, a critical approach, bibliographical and empirical up-to-dateness, and, if necessary, the ability to design;
- be able to communicate the results of their research in a clear and effective manner, highlighting analysis and synthesis skills.

The final examination for the Master's Degree in "Management of Cultural Heritage" will consist of a written thesis of a bibliographical, documentary or even experimental nature on a topic related to the themes carried out within the scope of the Course of Studies.

The thesis must be written in an original way under the guidance of a supervisor, identified from among the faculty and researchers of the Course; for the purposes of the final discussion, the Coordinator of the Degree Course or his delegate will assign a co-rapporteur to each thesis.

To enter the final examination, the student must have acquired the amount of university credits stipulated in the didactic regulations, minus those of the final examination. The final evaluation will be determined by the Commission by adding the grade achieved in the discussion of the Thesis to the average achieved in the Proficiency Examinations, translated into one hundredth of a second. The Master's degree may be awarded with honors at the request of the supervisor and with the unanimous approval of the Commission.

The parameters on which the evaluation of the thesis paper shall be based shall be as follows:

- a) as far as the written text is concerned, originality of the research, maturity and fluency of discourse, correct bibliographical research and up-to-dateness with respect to the state of knowledge related to the chosen topic, ability to analyze and synthesize, possible planning ability and good level of critical interpretation of the data resulting from the research;
- b) as far as oral exposition is concerned, clarity and ability to communicate in a synthetic form the results of the research, possibly also with the help of computer tools with respect to which the candidate must demonstrate full mastery.

## **Article 17**

### **Guidelines for traineeship and internship**

1. Students enrolled in the Master's Degree Program may decide to carry out internships or training periods with organisations or companies that have an agreement with the University. Traineeship and internship are compulsory and contribute to the award of credits for the other training

activities chosen by the student and included in the study plan, as provided for by Art. 10, par. 5, letters d and e, of Ministerial Decree 270/2004<sup>23</sup>.

2. The CCD regulates the modalities and characteristics of traineeship and internship with specific regulations.
3. The University of Naples Federico II, through the structures of the University, School and Department, ensures constant contact with the world of work to offer students and graduates of the University concrete opportunities for internships and work experience and to promote their professional integration.

## **Article 18**

### **Disqualification of student status<sup>24</sup>**

A student who has not taken any examinations for eight consecutive academic years incurs forfeiture unless his/her contract stipulates otherwise. In any case, forfeiture shall be notified to the student by certified e-mail or other suitable means attesting to its receipt.

## **Article 19**

### **Teaching tasks, including supplementary teaching, guidance, and tutoring activities**

1. Professors and researchers carry out the teaching load assigned to them in accordance with the provisions of the RDA and the Regulations on the teaching and student service duties of professors and researchers and on the procedures for self-certification and verification of actual performance<sup>25</sup>.
2. Professors and researchers must guarantee at least two hours of reception every 15 days (or by appointment in any case granted no longer than 15 days) and, in any case, guarantee availability by e-mail.
3. The tutoring service has the task of orienting and assisting students throughout their studies and of removing the obstacles that prevent them from adequately benefiting from attending courses, also through initiatives tailored to the needs and aptitudes of individuals.
4. The University ensures guidance, tutoring and assistance services and activities to welcome and support students. These activities are organised by the Schools and/or Departments under the coordination of the University, as established by the RDA in Article 8.

## **Article 20**

### **Evaluation of the quality of the activities performed**

1. The Didactic Coordination Commission implements all the quality assessment forms of teaching activities envisaged by the regulations in force according to the indications provided by the University Quality Presidium.
2. In order to guarantee the quality of teaching to the students and to identify the needs of the students and all stakeholders, the University of Naples Federico II uses the Quality Assurance

(QA)<sup>26</sup> System, developed in accordance with the document "Self-evaluation, Evaluation and Accreditation of the Italian University System" of ANVUR, using:

- surveys on the degree of placement of graduates into the world of work and on post-graduate needs;
- data extracted from the administration of the questionnaire to assess student satisfaction for each course in the curriculum, with questions relating to the way the course is conducted, teaching materials, teaching aids, organisation, facilities.

The requirements deriving from the analysis of student satisfaction data, discussed, and analysed by the Teaching Coordination Committee and the Joint Teachers' and Students' Committee (CPDS), are included among the input data in the service design process and/or among the quality objectives.

3. The QA System developed by the University implements a process of continuous improvement of the objectives and of the appropriate tools to achieve them, ensuring that planning, monitoring, and self-assessment processes are activated in all the structures to allow the prompt detection of problems, their adequate investigation, and the design of possible solutions.

## **Article 21**

### **Final Rules**

The Department Council, on the proposal of the CCD, submits any proposals to amend and/or supplement these Rules for consideration by the Academic Senate.

## **Article 22**

### **Publicity and Entry into Force**

1. These Rules and Regulations shall enter into force on the day following their publication on the University's official notice board; they shall also be published on the University website. The same forms and methods of publicity shall be used for subsequent amendments and additions.
2. **Annex 1** (CdSM structure) and **Annex 2** (Teaching/Activity course sheet) are integral parts of this Didactic Regulations.
